South Carolina has six Interstates and over a dozen rural routes criss-crossing it, all of which are the site of major truck wrecks that cause devastating injuries and cost lives. When fully loaded with cargo, a 53 foot-long commercial semi-truck—also called a big rig or tractor trailer—can weigh up to 80,000 lbs. It's no wonder that semi-truck drivers sometimes lose control of their rig, swerving recklessly, jackknifing, sometimes rolling on their sides and causing highway pile-

ups. The result can be catastrophic semi-truck accident injuries, including traumatic brain injury, spinal cord injury, broken bones, even paralysis.

A South Carolina Big Rig Crash Can Involve Complicated Trucker Insurance

If you were hit by a fatigued trucker driving recklessly on I-20, I-77 or I-95 or a drunk truck driver speeding along Highway 1 or Route 378, you will have to prove it to trucking company liability insurance adjusters and truck company lawyers.
